# What are the CE requirements for maintaining my New Jersey real estate license?

• New Jersey law requires all active agents to complete 12 hours of continuing education credits by April 30, 2023. To see the full list of requirements, <u>click here</u>.

#### When is the deadline for completing my New Jersey CE requirements?

- The New Jersey CE credits must be completed by April 30, 2023. You may submit CE credits until June 30, 2023 but will be subject to a \$200 late fee after April 30. If you do not complete your CE requirements by June 30, 2023, your license will not be renewed, and you will no longer be able to practice real estate until your license is reinstated.
- Agents licensed after June 30, 2022 do not need to complete CE for the 2023 Term.

## What opportunities do I have to complete my CE requirements?

#### Where can I track the CE credits I have completed so far?

#### I do not see credits for classes I completed in PSI. Who do I contact?

Be sure to make a note of who the provider is for each CE class you register for. Each provider is
responsible for uploading the credits to PSI upon course completion. If you do not see credits in
PSI for a course you have completed, contact the provider directly so they can assist with getting
your credits uploaded.

### I am a REALTOR® Emeritus member. Do I need to complete CE?

- Yes. REALTOR® Emeritus is a program ran by the National Association of REALTORS®. Emeritus members are required to complete the 12 hours of continuing education to renew their license in New Jersey.
- REALTOR® Emeritus members are only exempt from completing the National Association of REALTORS® Code of Ethics requirement every three years.

#### I have been a Broker for 40+ years. Am I exempt from completing CE?

- Yes. To qualify for the CE exemption, an applicant must have been licensed as a real estate broker or broker-salesperson for 40 years or more. Click here for full details.
- You must complete and submit the <u>40 Year Broker Exemption Application</u> provided by the New Jersey Real Estate Commission no later than March 15, 2023.
